

**Articles of Association**  
**Earth Energy & Gravity Association (EGA)**

*Let no one obstruct a member of this divine association.*

Name of Association: Earth Energy & Gravity Association

I Marcus E. Lee certify and attest that I have been endowed with the "Divine Right" to establish and promote the activities stated in the following articles. Said rights emanate from the "Highest Powers" and supercede all other ruling entities, including all governing institutions, bodies and/or their assigns.

The primary purpose of the EGA is the development, promotion, taxation, and regulation of energy technologies capable of supplying exotic power and transportation systems for the protection, benefit and welfare of Mankind.

Powers will include but not be exclusive of the following primary directives:

1. To develop, oversee, monitor, and regulate the use of exotic energy and gravity technology.
2. To promote the validation of said technologies within the scientific and engineering community.
3. To promote the licensing and taxation of such technologies to the worlds Governments.
4. To promote and establish a consortium of nations to oversee the proper implementation of the EGA's aforementioned technologies.
